However, I think that most Americans would support good legislation and policy changes that would help strengthen the position of the working middle class who are more likely to conduct business solely in the United States and actually hire people here, as opposed to Oligarch owned multinational corporations who have the means and ability to engage in wholesale Global labor arbitrage.

Here are two examples of the sort of legislation and policy changes that would help to strengthen the working middle class, actually create jobs, and help reduce our dependency on Chinese and other overseas manufacturing.

Example 1: "The Right to Manufacture in America Act" - a proposal for Patent Law Reform. (attached PDF)

Example 2: "The 10,000 Ounce Rule" - A proposal for Small business Funding (also attached PDF)

Note: I had originally written "The 10,000 Ounce Rule" with a focus on Israeli Law and the Global Jewish Community, but it could easily be restructured for inclusion into the U.S. Federal Tax Code and with disbursement of business funding delegated to the U.S. Small Business Administration. I also included background information with this proposal regarding it's creation process in order to help ensure that the context and spirit of the proposal would not be misunderstood or misinterpreted.

Furthermore, I would advise that the DSA should experiment with forming a new organization that does not have "direct ties" to DSA and use it to test the effectiveness of this shift in focus on strenghening the working middle class; you should name this organization something like the "Responsible Capitalist Party" or the "Small Business Alliance Party" (something that does not include the word Socialism or Socialist) and use it to promote the sort of legislation that I provided examples of above; and see if this organization garners more support than DSA.



SBA is unable to accept new applications at this time for the Paycheck Protection Program (PPP) or the Economic Injury Disaster Loan (EIDL)including EIDL Advances based on available appropriations funding.

EIDL applicants who have already submitted their applications will continue to be processed on a first-come, first-served basis.

Access to Other Types of Capital

SBA provides a number of loan resources for small businesses to utilize when operating their business: For more information on loans or how to connect with a lender, click here.

- 7(a) Program offers loan amounts up to \$5,000,000 and is an all-inclusive loan program deployed by lending partners for eligible small businesses within the U.S. States and its territories. The uses of proceeds include: working capital; expansion/renovation; new construction; purchase of land or buildings; purchase of equipment, fixtures; lease-hold improvements; refinancing debt for compelling reasons; seasonal line of credit; inventory; or starting a business.
- Express loan program provides loans up to \$350,000 for no more than 7 years with an option to revolve. There is a turnaround time of 36 hours for approval or denial of a completed application. The uses of proceeds are the same as the standard 7(a) loan.
- Community Advantage loan pilot program allows mission-based lenders to assist small businesses in underserved markets with a maximum loan size of \$250,000. The uses of proceeds are the same as the standard 7(a) loan.
- 504 loan program is designed to foster economic development and job creation and/or retention. The eligible use of proceeds is limited to the acquisition or eligible refinance of fixed assets.
- Microloan program involves making loans through nonprofit lending organizations to underserved markets. Authorized use of loan proceeds includes working capital, supplies, machinery & equipment, and fixtures (does not include real estate). The maximum loan amount is \$50,000 with the average loan size of \$14,000.



Dear VFI,

Twenty or twenty five years ago this soft call for Sayanim would have appealed to me as a exciting and rewarding way to serve my country and community. I'm not going to pretend that I am any scholar of the Torah or Talmud, most of what I know of these books comes from casually browsing Wikipedia on occasion to satisfy a passing curiosity. Even from this limited study It seems to me that Jews love good laws and policies.

We Jews have all sorts of interesting laws and rules, some old, and some like the Dead Sea Scrolls; recently discovered (and I'm sure there are a lot more undiscovered caves in the Holy Land.)

The laws regarding Shabbat: now that is a piece of work; but I am surprised that only a weekly Shabbat is mentioned, and not a "Lifetime Shabbat" or in other words: "Provisions for Retirement".

Shabbat should include lifetime limits on the amount of work a person can perform. These limits should be measured in a manner that is clear and ubiquitous to all, the value of Gold.

The "10,000 ounce limit"

For the value of 10,000 ounces of gold (some 281.25 Kg), a person who is not foolish or unwise with money, or extremely unlucky, could live without working, for their entire natural life in comfort and ease virtually everywhere in the world where there is relative peace and stability, and some respect for money.

A person who at any time in their life accumulates a net worth of more than this value of 10,000 ounces of gold (the "Obligated Person") would be obligated each Rosh Hashanah to grant (not loan) this excess wealth to a "Deserving Person or Persons" who will not squander it, but will use it for the betterment of the community by creating work, tangible goods, and wealth for others.

The limit for each "deserving person" to receive in a lifetime is the value of 1,000 ounces of gold.

A "Deserving Person" shall meet the following criteria:

1. The "deserving person" is not related closely to the obligated person and would be be permitted theoretically under Leviticus 18, to marry the "obligated person" (or their opposite sex sibling).

2. The deserving person has demonstrated that they are capable in productive labors / business and are proficient in handling money. This will be determined by having had a net worth greater than the value of 100 ounces of gold, but less than 1,000 ounces, for no less than 5 years.

Criteria: Money / wealth granted to "Deserving Persons" by "Obligated Persons" is granted for the purpose of "betterment of the community by creating work and wealth for others". Therefore this wealth can only be used for the following:

1. The purchase of Commercial, Agricultural or Industrial Real Estate that the "Deserving Person" will be operating an existing business from.


2. Equipment, tools, machinery, or stocks of materials or merchandise to expand or supplement an existing business.

All "deserving person" recipients of this wealth, must sign a legally binding contract stipulating that they too will abide by the "10,000 ounce" limit and grant their excess wealth to others in accordance with this law.




